

PropTech Festival 2025 Rules

Organiser

The organisers of the PropTech Festival competition are Polskie Towarzystwo Wspierania Przedsiębiorczości SA, with its registered office in Katowice, and PTWP-Online Sp. z o.o., with its registered office in Katowice, the publisher of the PropertyNews.pl and PropertyDesign.pl (herein jointly referred to as the Organisers).

Objective of the competition

PropTech Festival is an accompanying event of the Property Forum 2025, targeted at the creators of innovative real estate technologies. Creative, innovative, advanced, tailor-made for the market future and expectations – such are the inventions we want to promote and present to the heads of major companies operating on the real estate market: developers, investors, managers, and tenants. The PropTech Festival will feature meetings, debates, presentations, and demonstrations. Show your idea to investors!

Audience

We do not create thematic barriers – both start-ups and experienced companies developing innovative solutions for commercial facilities: office buildings, hotels, shopping centres, multi-family residential buildings, shops, warehouses, and public utility buildings – can declare their participation in the competition.

Cooperation and contacts with heads and representatives of the largest companies operating on the Polish commercial real estate market: developers, investors, managers, and tenants. Opportunity to present your solutions during the biggest commercial real estate market conference in the region – Property Forum 2025 and promotion on the PropertyNews.pl and PropertyDesign.pl websites and on social media.

Selection Criteria

1. Submissions are accepted via the form: <https://forms.gle/DqUsK2vB2APufp2N6>
2. Submissions are accepted until **11 July 2025**. Up to 4 photos can be attached to your submission by sending it to the following e-mail address: nagrody@propertynews.pl. The maximum size of an e-mail message may not exceed 10MB. In the title of the email, please enter the name of the competition and the name of the company. Sending photos as above is tantamount to giving authorisation to the Organiser of the Competition to crop and then publish the photos for the needs of the Competition and the granted award, if any, via websites and in printed press. The entity sending the photos guarantees that it is the holder of the right to grant the above authorisation.
3. The editorial offices of PropertyNews.pl, PropertyDesign.pl and Housemarket.pl together with the Jury select 10 most interesting entries which will be announced on those sites **by 21 July 2025**. Then, the readers of Propertynews.pl, Propertydesign.pl and Housemarket.pl vote until **31 August 2025**.
4. The next stage involves presentations of the best submissions. Finalists selected to proceed to the presentation stage will be notified by 3 September.
5. The winners will be selected during the Property Forum 2025, on **25 September 2025** – based on the Jury's and website votes.

Results and Award Ceremony

The statuettes will be awarded during the Property Forum 2025 Gala – **25 September 2025**.

Detailed information on personal data processing

1. The Organiser is the Controller (co-controller) of personal data collected during the submission process. For matters related to personal data, the Organiser can be contacted at: Plac Sławika i Antalla 1, 40-163 Katowice; odo@ptwp.pl.
2. The personal data collected in the submission shall be processed for the following purposes:

- a. to identify the submission and to proceed with the consecutive competition phases, including contacting the submitter, representatives of the submitted investments, to obtain additional explanatory information about the submission and the investments in the Competition, to inform about the results of the Competition, and to coordinate the investment representative's participation in the awards ceremony,
 - b. to inform about consecutive editions or similar competitions, direct marketing of services and communication between the data controller and investment representatives, in the form of written or electronic communication, or using telecommunications devices (telephones, text messages).
3. Data processing involving the collection, storage and sharing of data obtained in connection with the competition is necessary to fulfil the above-mentioned legally justified purposes carried out by the above-mentioned controllers.
4. The data shall be processed solely for the time required to accomplish the processing purposes, however, not longer than until the time an objection is made to processing or the consent to process the data is revoked. Objection to the processing of personal data or the mode of processing can be submitted at any time at odo@ptwp.pl.
5. The person whose personal data has been provided in a competition submission shall be entitled to access their data and to correct it. Such person may at any time request the rectification, deletion, or restriction of the processing of their data; such person is also entitled to object to specific processing and is entitled to lodge a complaint with a competent supervisory authority pursuant to the terms and conditions set out in relevant legislation.
